Magic Valley Electric Cooperative, Texas Electric Cooperative, and the National Rural Electric Cooperative Association will co-sponsor a tour of Washington, D.C., its monuments, the Capitol, Smithsonian Institute, and other historical and political sites. This year's delegates from our local area will join over 120 delegates from Texas. Together, they will visit important landmarks as they travel to our Nation's capitol, where they will join over 1,200 delegates from across the Nation. This will provide an avenue for each representative to learn and become familiar with our government's operation and history.

Contest Rules

- 1) This contest is open to high school sophomores and juniors living in MVEC's service area and whose family is a member of Magic Valley Electric Cooperative.
- 2) Immediate families of Cooperative employees or directors are not eligible.
- 3) Each contestant shall submit one completed application. Applications may be obtained from any MVEC office, your high school counselor's office, or online at www.magicvalley.coop.
- 4) Two letters of reference, one from a present teacher or principal, must accompany the application.
- 5) Mail the completed application, permission form, letters of reference and copy of MVEC bill to:

- 6) Entries must be postmarked by January 10, 2024.
- 7) Applications will be scored and finalists will be interviewed in order to determine the winners.
- 8) Four winners and an alternate will be named. The alternate will be asked to represent the Cooperative in the event one of the winners is unable to attend.
- 9) The winners will be presented at the Magic Valley Electric Cooperative Annual Meeting on April 15, 2024. Attendance by the winners is required.
